# **Psychiatric Rehabilitation Program (PRP)**

#### **Client Activities**

Our clients have been busy enjoying the outdoors and getting as many activities in as we can before winter weather reaches us. - 1 client successfully managed spending habits
- 1 client has maintained sobriety from drugs and alcohol for 10 months
- 1 client recognized her need to utilize crisis/respite authorizations for Safe Harbor rather than engaging in selfinjurious behaviors
- 5 clients applied for and received entitlement benefits with help from their case manager
- 2 clients began attending on-site PRP more frequently to increase socialization

# **Residential Rehabilitation Program**

#### Cameras

# Residential Crisis Services (RCS) & Respite Services (RPCS)

#### **Client Accomplishments**

- 1 client was admitted into inpatient addictions rehab
- 1 client moved into a Residential Rehabilitation Program
- 6 clients obtained a private residence
- 11 clients returned home after completing their crisis authorization
- 1 client was admitted into long term rehabilitation services
- 3 clients obtained a primary care provider
- 1 client began receiving pain management services
- 4 clients applied and were approved for entitlement benefits
- 1 client began treatment at a Community Treatment Center
