


### Client of the Quarter

## Residential Rehabilitation Program (RRP)

The Residential Rehabilitation Program houses received a fall cleaning and basic maintenance before the severe weather arrived. Almost all or 83% of the Residential Rehabilitation clients received their first dose of the COVID-19 vaccination. Both Residential Rehabilitation Program staff members have received the first COVID-19 vaccination as well. All in all, both houses are operating at full potential during the pandemic.



## Residential Crisis Services (RCS) & Respite Services (RPCS)

Both Residential Crisis houses have continued to stay open throughout the pandemic. Respite has been paused for the time being. Residential Crisis Services continue to help people obtain somatic and psychiatric care, as well as obtaining Medicaid and ID's. Some clients have been admitted into longer term treatment and some have transitioned into independent living. About 50% of Residential Crisis staff have received their first dose of the COVID-19 vaccination. Although the pandemic has kept clients from attending Mental Health IOP for most of the year, it has given us the ability to do IOP virtually for both Safe Harbor and Compass House.
